Dear Attorney General Ford,

I write the following to you because my most basic rights of attaining body camera footage from the Las Vegas Metropolitan Police are being violated. I have already paid for this body cam footage, which occurred over a month ago now.

I detail the history of the matter herein.

- On October 13, 2024, two Anti Terrorism LVMPD officers attempted to enter my parents home in Las Vegas, 89149.
- My parents, Berj and Sonia Yenovkian, refused to allow entry to the two LVMPD Anti Terrorism Officers.
- On October 14, 2024, 'up to 12 LVMPD Anti Terrorism officers" descended upon my parents home.
  - They had no warrant.
  - Sheriff McMahil has stated to Steve Sanson that this incursion upon my parents home was not authorized.
  - The Anti Terrorism officers acted in a threatening manner toward my parents, who are 82 and 77 years old, elderly individuals.
  - My parents were terrified.

- Until today, my elderly parents have trauma from this event that has effected their health, wellbeing, and finances.
- The Head of the Anti Terrorism unit stated that they were there on a "welfare check" on October 13, and October 14, 2024.
- My parents stated that their welfare was fine, yet the 12 Anti Terrorism officers refused to leave on October 14, 2024
- Only when Steve Sanson called various Judges, and Sheriff McMahil, only then the Anti Terrorism officers decided to leave on October 14, 2024.
- Following these incidents on October 13, and October 14, 2024:
  - Immediately, the witnesses and victims to these events filed complaints with the Citizens Review Board and the LVMPD. These witnesses and victims are Steve Sanson, Berj and Sonia Yenovkian. The Complaints are attached herein as EXHIBITS 1 to 3.
  - Despite filing these complaints immediately, incident numbers were not issued and conveyed to us until weeks after the filing of these incident numbers.
  - Steve Sanson and Vem Miller had to pay two personal visits to the LVMPD, both documented by a journalist, in order for LVMPT to relent and give the incident numbers.

Body Cams:

- Body cams were requested by Steve Sanson and I, under the Freedom of Information Act.
- That Request is attached under EXHIBIT 4.
- A bill was sent for \$1283.73 for said body cams.
- This bill was paid November 7, 2024. Proof of this is attached as EXHIBIT 5.
- On December 6, 2024, Steve Sanson was told that it could take up to 18 Months to attain said body cams.
- On December 7, 2024, Steve Sanson wrote an email to Sheriff McMahil stating that it was ridiculous that body cams could take up to 18 months, and this was clearly an attempt to cover up and

frustrate what is ultimately a threat of exposing corruption and bad behavior of the LVMPD. This is attached as EXHIBIT 6.

### Prayer for Help from Attorney General Ford in Attaining Said Body Cam footage in an expeditious fashion

- It is my statement, Vem Miller, that the reason the LVMPD are trying to frustrate the attainment of body cams is in order to help frustrate and / or cover up progress in my lawful actions against those who grossly violated my rights, and the rights of my family, starting October 12, 2024.
- Attorney General Ford, I know that you are sensitive to police misconduct and abuse of power.
- I firmly believe that this incursion upon my parents home, on October 13, and 14, 2024, by the LVMPD, was an abuse of power, at the minimum.
- Now they want to cover up their own mistakes.
- This body cam footage will be embarrassing to the LVMPD, but it should be embarrassing, and without it being embarrassing, the type of training and reforms that are necessary, wont take place.
- The recent "accidental shooting", or some would say, murder, of Brandon Durham, is further evidence that the LVMPD has gaps in process and training.
- The LVMPD Anti Terrorism Unit had descended upon my Parents home because they thought I lived there, and because they were given some <u>false information</u> about me. So in the heat of that moment, I could have been Brandon Durhammed.
- I truly believe there is good chance that due to the continued errors of the LVMPD, I would have been dead had I been there when they tried to conduct their warrantless entry into my parents home.
- And now you would be dealing with the clean up of an innocent man being killed Attorney General Ford, which of course would be a head ache for you.
- The solution is Freedom of Information, but right now, the LVMPD is preventing us from getting that information, and whereby a normal delay

would be 10 days, they are trying to extend this to 18 Months in order to frustrate the lawful process.

 Therefore, I ask Attorney General Ford that you step in and compel the LVMPD to release the Body Cam Footage in question, urgently, as we are already past the permissible wait time once footage has been paid for.



Attention PIO and Sheriff McMahill:

I was told that the body cameras would take up to 18 months. This method is used to run out the Statue of Limitations. I would need to know in writing as to the amount of time it would take for these images to be in my custody. According to the FOIA request it should be a reasonable amount of time and the FOIA also indicates if it takes longer than 15 days I should be contacted in writing. This process has not taking place.

The time frame for police to respond to a Freedom of Information Act (FOIA) request, including requests for body camera footage, depends on whether the request is made under federal FOIA or a state-specific public records law. Here are the general guidelines:

Federal FOIA Requests

Federal FOIA Requests

• Agencies must respond to FOIA requests within 20 business days after receiving the request.

• This period can be extended by an additional 10 business days if the agency cites "unusual circumstances," such as the need to search multiple locations or consult with other entities.

Exceptions for Body Camera Footage

Some states or agencies may deny or delay access to body camera footage due to:

1. Ongoing Investigations: If releasing the footage would interfere with a case.

2. Privacy Concerns: When footage contains sensitive or private information.

3. Redaction Needs: Additional time may be required to redact parts of the footage.

What You Can Do if Delayed

• Follow Up: Politely inquire about the status of your request if the deadline passes.

• Administrative Appeal: Challenge the delay or denial through the agency's appeal process.

• Litigation: File a lawsuit for non-compliance if the agency fails to respond within the legally mandated time.
