I'm writing to you about multiple

complaints and grievances against the Riverside County Sheriff's Department and Sheriff Chad Bianco. Im looking for your help and assistance in these matters. Background: On October 13, 2024, Sheriff Chad Bianco of the Riverside County Sheriff's Department falsely accused me of trying to assassinate President Trump, of being a "lunatic", of having ill intent for the President, of having Fake IDs, and many other false accusations. Assassin. I was given a ticket on October 12, 2024, which is attached herein as EXHIBIT 1, a misdemeanor, which I state was under false pretenses and fraud. Non the less, this citation, is something common. Somehow, Chad Bianco turned this into an attempted President Trump assassination. He lied about everything under the sun, was there to kill the President, was there to cause harm 100%, said I had fake lds, that I was antigovernment, a sovereign citizen, that I was a lunatic, and more. Anything that came out of his mouth of substance was a lie. I have since learned that he was doing this to gain the attention of the mainstream media, because he is planning on running for California Governor. He wanted to seem like a hero in front of the world, even if it meant the complete destruction of my life and framing me for a crime I did not commit. This was complete character assassination. This was also using public funds and resources for his own personal ambitions. Today, a search for Vem Miller returns lies that I am anti government, an assassin, a person with fake ids, a criminal minded person, etc. All lies. Imagine being Vem Miller and trying to get a lease, a job, go on a date, and anything else normal people do, after the havoc that the lies of Sheriff Chad Bianco have reaped upon my life. What am I looking for from AG Rob Bonta? 1 - I requested the body cam footage of October 12, 2024 from the Riverside Sheriff's Department. I was denied. I attach the first denial as EXHIBIT 2. I appealed the denial, and this time, I got a response from the lawyer at the Riverside Sheriff's Department. I attach this second denial via the lawyer as EXHIBIT 3. The grounds for denial of the Body Cam footage, are based upon lies. There is no investigation into this matter, unless Sheriff Bianco has fraudulently launched one to avoid the inevitable revelation of the truth. I ask that AG Rob Bonta use his lawful powers to expedite the release of all the Body Cam footage pertaining to the events of October 12, 2024, into my possession, as I have outlined in my FOIA and CPRA requests, attached herein as EXHIBIT 4. 2 - What Sheriff Chad Bianco has done, in knowingly lying, causing international defamation, and trying to frame an innocent person for a crime they did not commit, is a clear violation of protocol under POST (Peace Officer Standards and Training) and California Senate Bill 2. Under those two guidelines, the Decertification of Chad

Bianco and David Coronado is warranted. Therefore, I ask that AG Rob Bonta send a high recommendation that Senate Bill 2 be exercised, and that Chad Bianco and David Coronado be decertified for knowingly reporting false information, and trying to frame a person, which is also a felony under 18 U.S. Code § 1001. 3 - There are multiple Civil Rights issues pertaining to the conduct of Sheriff Chad Bianco and the Riverside Sheriff's Department. The Body Cam footage will reveal many more than the ones currently being discussed at this juncture. For example: I was deprived of much needed water and medical supplements. My ill medical state was used to conduct an unlawful search and seizure of my car. Officers knew this was completely unwarranted. Many other legal and ethical violations. I would like AG Bonta to launch a deprivation of Civil Rights Investigation into the conduct of Chad Bianco and the Riverside County Sheriff's Department. The issue I want to point out to AG Rob Bonta is how the fact that I am a Dual Citizen was so badly demonized by Sheriff Chad Bianco, in trying to make the simple fact that I have two passports into reasons to suspect me for being an assassin. The primary reason for the name change between my US and Canadian passport is because my Christian Armenian last name could get me killed in many regions of the Near East or Middle East, where I planned to do Investigative Journalism. When I had the opportunity to do a name change in order to have this protection, I did so. It was all lawfully done. I have done research on how common it is for people to have dual citizenship, and different last names in their US Passport vs Passport from their country of Birth. There are over 110 members of congress, in the United

States, that have 2 Passports, and 1 drivers license. On a low account, there are over 11 million people in the United States that are dual citizens, but some believe that number could be as high as 40 million. 33% of immigrants change their last names within the first 10 years of arriving to the USA. Historically, changing of names was a practice in Ellis Island where many new immigrants landed. Names would be "Americanized" Other immigrants would have reasons pertaining to persecution and asylum. Therefore, Nothing is unusual when there are tens in the million doing the same thing. It was logical, lawful, and somewhat common. But Bianco exaggerated and dramatized how many passports I had, my id, their authenticity, all aimed at making me sound like sound like an international assassin with a briefcase of passports and fake IDs. According to Bianco: Any one of the 33% of immigrants that change their name when they come to the USA could have fallen prey to this, simply because they have one passport with their new name, and one with their old name on it.
